## Eat & Chat Presentations, 2023 and 2024

The first 2023 Eat & Chat presentation took place on April 23, from 11:30 a.m. to 1:00 p.m., in the conference room in the Model Mill building on State of Franklin Road. Dr. Scott Honeycutt (pictured right), Associate Professor in the Department of Literature and Language, and Secondary Education Coordinator, gave a presentation on book banning, including a short history of banning from the nineteenth century to the present and reasons for banning of certain texts. At present, in the US, local governments, parents, school boards, and politicians, may override book selections by educators and ban certain texts from being read by public school students. Reasons for banning usually relate to objections to content being sexually explicit, relating to LGBTQ+ identity, or language being “offensive.” Some currently-banned texts are Art Spiegelman’s Pulitzer Prize winning *Maus*; *The Kite Runner* by Khaled Hosseini; and *Gender Queer: A Memoir* by Maia Kobabe. As the department’s student-teacher supervisor, Dr. Honeycutt commented on the impact of book banning on student teachers. Approximately 35 brown-bagging individuals enjoyed the presentation and the question and answer session that followed.

The second 2023 Eat & Chat took place on August 23, 10:30-noon, in the ETSU Planetarium, Room 207, Hutcheson Hall. Using the planetarium’s visual sky program, Dr. Gary Henson (pictured below), Director of the Harry D. Powell Observatory and the ETSU Planetarium discussed the

formations of major constellations, history and mythology associated with them, and where they can be seen in the Northeast Tennessee sky at different seasons of the year. After the question and answer session, a number of the 40 or so attendees made their way to the Main Meal in the Culp Center for lunch and additional conversation.



The first Eat & Chat program for 2024 took place on February 7, again in the conference room of the Model Mill, noon to 1:30. The featured speaker was Dr. Scott Contreras-Koterbay, of the departments of Art & Design and Philosophy. He also serves as Director of the Bert C. Bach Fine & Performing Arts Scholars Program in the Mary B. Martin School of the Arts and Interim Director of the Martin School. Contreras-Koterbay’s presentation, “Helping to Shape the Future of the Arts at ETSU,” focused on changes in the scholars program, the Honors College, and the efforts to maintain an educational emphasis on the arts in a time when arts education nationwide has faced criticism.



## 35<sup>th</sup> Annual Summer Luncheon

The 35<sup>th</sup> Annual Summer Luncheon took place on June 21, 2023, in the meeting room at the Johnson City Food City, 920 N. State of Franklin Road. **Second Harvest Food Bank.** ETSURA members continue to volunteer for the Second Harvest Food Bank of Northeast Tennessee, every second Wednesday morning (8:30 a.m.-noon) of each month. Second Harvest, 1020 Jericho Dr., Kingsport, helps school children with backpack food items, seniors with food boxes, and anyone who needs assistance with the organization's mobile food pantry. # 35<sup>th</sup> Annual Meeting and Luncheon

ETSURA’s fall meeting and luncheon took place on November 15, 2023, in the Taylor Room of the Carnegie Hotel. Attended by 58 or so retirees, the event featured two speakers: Angela Hagaman, Research Assistant Professor in the ETSU College of Public Health and Co-director of the ETSU Addiction Science Center (ASC) and Marissa Kluk, Director of Recovery Ecosystem alignment for the ASC. Their presentation summarized epidemiological data related to substance use disorder, and fatal and non-fatal overdose in East Tennessee

and Central Appalachia, two areas hard hit by opioid use disorder. The presenters also reviewed the latest evidence on supporting individuals who seek help for substance use abuse and related concerns. The presentation also provided an overview of the Northeast Tennessee Recovery Ecosystem Asset Map and the National Recovery Ecosystem Index. After the speakers finished their informative talks, audience members followed up with questions.
