Discussion regarded:

OB/GYN

- Use of dynamic teaching methods, e.g., “exotic” cases, thinking beyond a common problem, including in HPS lab; interactive learning = “*doing* things”
- Observation of H&Ps; percentage of grade based on each core competency
- Dr. Herrell’s customized materials and his encouragement to read the textbook
- Plans for doing their own CLIPP-type (Computer-assisted Learning in Pediatrics Program) cases/tutorials and for timesaving, flexibility of videotaped lectures

PSYCH

- Inpatient exposure except for one week of outpatient (for Generalist track students); weekend call at Woodridge
- Work with a treatment team, plus significant one-on-one time with preceptors
- Emergence of skills beginning with observation
- Use of ethics cases

In general

- Dr. Olive stated these directors are one of the strengths of their clerkships
- Benefit of sharing information among the clerkships and interaction among disciplines
- Importance of having and involving quality residents (some QCOM grads)
- Potential of HPS lab
- Competency-based evaluation of students; evaluation of professionalism
- Challenge of the transition to New Innovations
