Action items from this year:

Reviewed 16 Campus Sustainability Fee proposals for the 2021-2022 academic year. Voted to fund 6 of the 16 proposals submitted. Projects included LED lighting upgrades for 5 rooms at ETSU Kingsport Allandale Campus, LED lighting upgrades at Lyle House, LED lighting upgrades in all common hallways of Warf-Pickel, funding for the Department of Sustainability Graduate Assistant position, funding for marketing and promotion of events for the Department of Sustainability and EcoNuts, and LED lighting upgrade to the Appalachian Studies Multipurpose Room (Nicks Hall, Rm 225). The approved projects totaled over \$73,000 in sustainability related projects on ETSU's campuses.

Pending Issues or Action:

<u>Pending Action:</u> This academic year we changed to a once yearly acceptance of proposals, once in the Fall semester instead of twice a year (once in the Fall and once in the Spring). This will allow us to track the spending of funds more easily. We also hope this allows for projects to be started and completed sooner within the academic year that the proposal is for.

Currently exploring restructuring the committee makeup and updating the charge and requirements of the Committee.
