- 1. Celebrations
 - 1.1 **Epps** announced that she would need to leave the meeting early to attend the press conference for the new basketball coach.
 - 1.2 **Collins** is officially retiring this summer. He has been teaching for thirty-eight years.
- 2. Introductions of Guests
 - 2.1 Amy Johnson, Associate Provost for Faculty & Director, Center for Teaching Excellence
- 3. Announcements
 - 3.1 There will be a Town Hall with Dr. Noland on April 20 at 1:30pm.

- 3.2 **Sergiadis** announced that Sherrod Library has an Electronic Textbook Reserves Program where the library purchases e-textbooks that are required for classes under an unlimited license, meaning every single student in a course could access the textbook at the same time. If instructors wanted to check if their course textbooks is available to purchase, complete the Suggest the Purchase form (https://etsu.illiad.oclc.org/illiad/illiad.dll?Action=10&Form=30&&rft.genre=other). The library does receive information from the bookstore to find out what textbooks instructors are requiring and whether they can purchase them. However, they sometimes do not get that list until closer to the beginning of the semester.
- 3.3 **Brown** announced that he would no longer be serving on the Faculty Senate next year so the position of Parliamentarian is position is available. The Faculty Senate Executive Committee appoints this position. If interested, contact him and he will share his training materials.

4. Guest Speakers

- 4.1 Mr. Jeremy Ross Facilities Update
 - 4.1.1 Ross provided update on campus facilities.
 - Ross provided a list of Capital Disclosures: Admission Renovation, Sam Wilson Renovation & Addition, John Robert Bell Drive Upgrade, Memorial Center Exterior Upgrade, and Boulevard Commons Extension. These are projects that we might pursue, but it does not mean that they have funding.
 - ETSU received \$11.3 million for maintenance, which was \$2 million more than what we were expecting.
 - ETSU submitted a new Academic Building (\$52 million) request. The Governor did not recommend it so it is not in the government's budget. It ranked #5 on THEC Capital Outlay Recommendations. Numbers 1, 2, 3, 4, 7, and 9 were recommended for funding by the Governor. There is still a potential that it could be funded.
 - VA Building 2 for Orthotics and Prosthetics and Occupational Therapy (\$4 million) is in the early stages of being built.
 - Boulevard Commons will be open on April 16. There will be swing sets, horseshoes, and a clock with a recognition to faculty and staff, and shuffleboard. There is a space in Carter Hall for a bakery or candy shop.
 - He provided some images of what they are considering for the future: amphitheater steps
 near Lamb Hall, new quad behind Lamb Hall, green space in front of Clemmer, new turn
 around in front of Brooks Memorial Hall with accessible parking, pathway to connect the quad
 behind Sam Wilson and Lamb Hall, paving on top of the amphitheater near the Culp Center.
 - He provided a list of summer projects: Lamb Hall (\$23 million) is starting to get ready for construction. The Fine Arts Center has \$1-2 dollars of work left, mostly around technology and equipment. The Culp Center still has some construction left. Brown Hall has chemistry lab renovations. There are housing renovations and maintenance such as HVAC renovations to Buc Ridge. The Memorial Center mini dome is being worked on to increase capacity for graduation (new doors, entrances, code corrections), University Commons is still being improved. We are beginning to get a Master Plan for Innovation Park, the site behind Fresh Market. This could potentially include a new building for the College of Medicine.
 - 4.1.2 Ross asked for questions and feedback.

Kahn: Is there a plan to have a new building to house the Department of Computer Science. Right now, we are in Nicks Hall. I want to see a field like Computer Science have a state of the art building because it is one of the most sellable majors that can attract students across the state and world.

Ross: The New Academic Building will be focused around some arts and sciences programs, specifically general education. I am not certain that particular building would house Computer Science. The renovation to the Millennium Center may receive some of the Cyber programs. As more of that space is being renovated, it could be an option. There may be some creative ways to find space in there for some faculty.

Kahn. The issue with the Millennium Center is that it is hard to change the original vision of the building. The vision has changed to be more academic focused - labs, offices, etc. It is hard to house that in a building that did not have that kind of vision. For example, you have tall ceilings and you do not want to put offices in that kind of space.

- 4.2 Dr. Ginni Blackhart Provost Academy Scholar
 - 4.2.1 Blackhart presented on Digital Measures.

Digital Measures is a software tool that allows faculty to record their activities (teaching, research, service, community engagement). Once you input information, it stays in the system. This is helpful when you have to report the same information multiple times (annual evaluations, tenure/promotion, and accreditation purposes). Through what is called Workflow, faculty can create reports for these things. It is going to be more work for faculty on the front end, but it will make our lives easier. We have been working on this since January. We are starting to be trained in using Digital Measures so that we can train other people. I have been speaking with deans, department chairs, and other stakeholders to share what Digital Measures is and what it can do, but also collect information to ensure that we are recording all of the information needed with Digital Measures. I will begin training early adopters probably at the end of spring/early summer. We will be begin training 12-month faculty in the Summer and then continue faculty and staff training into the Fall with everyone on campus trained to use it by the end of 2021. When you enter information into Digital Measures, only certain people can access your information such as your department chair and dean. Regular faculty cannot just pull the information from your profile. We are going to be using this for annual evaluations and for the tenure and promotion process, graduate faculty status, faculty credentialing, accreditation purposes, and anything else that we need to collect and report information. Since the whole campus is using it, we will have better data so that we can really promote what faculty are doing on our campus.

4.2.2 Blackhart asked for questions and comments on Digital Measures.

Hemphill: Is this the same program, that we heard a presentation about sometime last semester. The same one that UT Knoxville may use or the UT Systems uses?

Blackhart: I know that the UT Health Sciences Center uses Digital Measures. I do not believe that the entire campus uses it. I am not sure whether it is the same program that you heard about last semester or not. I came on board into this in January.

Foley: This is something we had asked for about four years ago. I am glad the university is finally acting on it. In the end, it will be much more efficient use of our time.

Blackhart: I agree. The biggest hurdle is going to be the work up front in terms of putting our information in. Some neat tools help us do that. For instance, there is an option where you can upload your CV into Digital Measures and it will populate certain areas within Digital Measures. There is also the option in terms of publications. It does not work with Digital Commons, but it does work with Mendeley, RefWorks, PubMed, Google Scholar, and a few others to pull publications. Newer faculty are going to benefit from Digital Measures a lot more than people like me who have been around for a long time.

McGarry: I was wondering if you had tested the system with a selection of faculty on campus.

Blackhart: Not yet. In fact, I have not even gotten to get into the system and play around with it yet. That is part of what we are going to do with early adopters. I have been talking to people in different departments and colleges around the university to find a group of early adopters. Some staff members, newer faculty, faculty who have been around for a while, faculty who are tech savvy, faculty who are not tech savvy, etc. to test it and validate it. We will be doing that late spring or early summer.

McGarry: I would feel better if you included at least one person from Music. Systems tend to be particularly unfriendly to the Department of Music as a general rule.

Blackhart: I will definitely reach out to the faculty in the Department of Music because you have a really good point. Those of you who are on Faculty Senate, let me know if any of you would like to be an early adopter or you know of faculty who would like to be early adopters. Just send me an email and I will add you to the list.

Kahn: Traditionally, when you go up for tenure, you upload it all in one place and it is e-mailed to everybody. Would this be still an option? Or how would this work?

Blackhart: No, Digital Measures will replace the promotion/tenure system once we get it fully up and operational.

Dunn: I know a lot of my faculty are more on the creative side of things. If I am a documentary filmmaker, for instance, that does not translate well to publications and things like that. Does it have a lot of built-in flexibility for that sort of creative work that goes beyond the traditional scope of publications?

Blackhart: Digital Measures is highly customizable. In that way, the departments define scholarly activities, scholarly and creative activities for their faculty. There are many different ways that we can record that in Digital Measures. That is one of the reasons why I am meeting with the deans and chairs. Since you will be the chair of your department soon, I am meeting with you just to make sure that we collect all of the information that each college and department will need for such things.

Byington: We have very few tenure-track faculty in our department or even tenured faculty. Has anyone looked to see how the system works for those who are not on a tenure-track?

Blackhart: I do not have the answer to that. I do know that other institutions that currently use Digital Measures have experience with that. I am not entirely sure how it works. The evaluation process will not change. We will be using Digital Measures, but we are not mandating that departments change the way they evaluate faculty, for instance. You would still use Digital Measures to collect activities for non-tenure track faculty as well and evaluate them in the same way that you always have.

Fiuza: I have a question concerning current recordings that we might have. Can those count for that project as well? Because through the pandemic, I probably recorded about 10 events so far.

Blackhart: That is not a question that I can answer. That is more at the departmental and college level in terms of how they would count that toward your scholarly activities. It is definitely something that you could record within Digital Measures.

All of our meetings for the Fall will be conducted via Zoom. It is yet to be determined whether we will meet in person or on Zoom for the Spring semester. **[Senator]** stated that October 11th is during Fall Break. **Collins**, **Brown**, and **Foley** noted that Faculty Senate does not normally meet during Fall Break. Blackhart stated that the Executive Committee would discuss and come up with a plan.

7.4 Motion – Dr. Dunn

I move that faculty senate recommends that East Tennessee State University creates and adopts a policy on non-patentable intellectual property in alignment with the AAUP's policy on the same (https://www.aaup.org/report/statement-intellectual-property)

Dunn introduced the motion. The legal office feels that everything that we do as professors is sort of work for hire and that ETSU owns everything we do. When we look at the intellectual property policy in the Faculty Handbook, it just refers to a document on research. Legal would be open to us finding another way of defining intellectual property. He recommended the AAUP's perspective on intellectual property. This is a pressing issue with the drive to put more classes online and agree to MOUs.

Byington: There are mechanisms other than resolutions to get communications going between the administration and the Faculty Senate. We could have a motion to ask the Faculty Senate President to do X or Y or whatever.
