  - b. 4/29/21: Concern came in via Staff Senate website: “How does Gov. Lee’s decision affect ETSU mask mandate?”
    - The standard reply was sent and the concern was routed to committee for comment
    - **Governor Lee EO 80:** EO 80 (Executive Order 80) removes the local authority for county mayors in 89 of the state’s 95 counties to require face coverings throughout their jurisdictions. Effective 4/28/21
      - As a committee, some interpretations of the general statements Governor Lee was making differed, but as related to the order, it does not affect ETSU. ETSU has not followed state or local government suggestions or mandates from the beginning, but rather referred to CDC and local medical and health experts in the region for recommendations and guidelines.
      - Our response highlighted that the executive order from Governor Lee doesn’t require ETSU to drop the mask mandate. It orders Mayors to not require face coverings in their jurisdictions. Also noted was that ETSU has followed CDC recommendations regarding COVID-19 protocols and best practices for campus, and announces those changes as they evolve. So, we will continue read our weekly emails for updates and refer to the websites regarding COVID-19 and face coverings (links were given).
