Learning Services- Discussed the programs available at the CFAA such as tutoring, supplemental instructions, and academic coaching. Aims to spread what they CFAA-LS is and the programs they offer, alongside who they work with, which is mostly student based.

**Tutoring-** Provide one-on-one assistance with coursework, writing, speaking, test prep, and study skills. They have more that 500 courses. They are open 7 days a week and have the chance to do online or in person.

Supplemental Instructions- targeted support in historically difficult course with DFW rates. SI leaders attend lectures with students. The benefits to attending to SI are that they can earn final grades that are a full letter grade higher.

**Academic Coaching-** incoming freshmen are paired with an upper level ETSU student to help them develop the skills they need to be academically successful

**Challenges-** limited full tine staffing, COVID budget cuts, budget allocations, high turnover and competition for best students employees, upcoming changes to APS/FWS positions, borrowed tutors.
