- Meeting with Keith Glover was postponed to March 9th, going to plan a committee meeting for late March to discuss that and a few new agenda items.
- Reported Concern(s):
 - 1. Concern received by Candy, Sent to Emily 2/16/21: Can a staff member keep their ETSU email upon retirement?

Answers from ITS:

Maybe, if they fit the criteria being alumni or emeritus. They might be able to keep their email account. There are some exceptions:

- If their department decides to keep the address.
- They could get a new alumni address.
- If they have confidential information in their mailbox it may be wiped and they would get a blank mailbox.
- 1a. Emily's follow-up question: We are aware that students and some faculty with emeritus status can keep their emails after they leave. If a staff member was a student but lost their ETSU email upon retirement, who is the contact to get this reinstated?

Answers from ITS:

They could contact the helpdesk to request an alumni account.

Now all this is up to change. There is a large cost for the infrastructure for spam and malware filtering. I have proposed the creation of an alumni domain. Where alumni still have an email account, but it would be handled differently. Some of the email delays we have seen where spammers are blasting all the email accounts they have collected over the years and we receive 100K messages in a 20-minute window.

1b. 2nd follow-up question: If an employee is about to retire and requests an alumni account to replace their ETSU account, can contacts and archived emails be moved over to that account by ITS before the ETSU account is terminated?

Answers from ITS:

This would be up to the department (maybe university council), as there may be FERPA/HIPAA data in the account. Due to limitations, you can only have one email address listed in banner per E#. We can export mail/contacts to a PST file, but the user is responsible to import the data into the new account. This is a very manual and time-consuming process for my team.

The Staff Concerns committee reviewed this concern and were satisfied with the answers. The information was sent to the staff member and it was received with appreciation.

ETSU Day of Giving - April 15, 2021 Talking Paper for Leadership

What is Day of Giving (DoG)? Marketing efforts and other activities designed to leverage modern means of communication (e-mail, web, social, video, etc.) to identify and engage donors and receive new/continuing annual support for ETSU. We intend this to be an annual event.

What is the Theme? We will use Bucky and "Flat" Bucky (a mail-able version) to promote Day of Giving. We will ask alumni/friends to take pictures with Bucky and post to social media using #FlatBucky and #ETSUDayofGiving. A video on a similar theme will be produced to release just prior to Day of Giving. We will run virtual competitions (an at-home scavenger hunt). Winners will get to direct \$1,000 in funding to ETSU areas.

When Will This Take Place? April 15, 9:00 a.m. until April 16, 8:59 a.m.

What is the Goal? We aim to exceed 800 donations during Day of Giving.

How Will We Achieve This? We will apply techniques/tools to build excitement, gamify the giving experience, add elements of competition, and develop a sense of urgency among all potential ETSU supporters. We will identify "lead gifts" and publicize those, offering early access to our closest friends and partners. We have a cross-university committee leading the initiative. Advancement will send a series of e-mails and social media posts centrally and we are asking all units, faculty, and staff to share with their alumni, friends, parents, partners, and friends.

Key Events:

- *April 1, 2021, Soft-launch* committee, DoDs, Foundation, All-Stars, and leadership will be invited to create online accounts, make plea videos, and consider matching/challenge gifts.
- April 1, 2021, 10 a.m. release video featuring Dr. Noland and Bucky (re-shoot may be needed).
- April 8, 2021, 10 a.m. all faculty/staff will be invited to visit the GiveCampus portal to make gifts, post videos, and share.
- Throughout DoG e-mails/social media posts; progress updates.
- April 8, 2021, 8 a.m. GiveCampus portal open to everyone.
- April 16, 2021, noon Thank You e-mail/video to all donors (cards/letters to follow).
