- 3.2 **Epps** announced that nominations for the All SoCon faculty and staff team are still being taken. Faculty members of the Intercollegiate Athletics Committee will select the faculty member. The winners will be recognized at an ETSU home basketball game. A nomination form will be sent to senators after the meeting.
- 3.3 **Brown** announced that Alan Forsman has been out all semester with a broken neck and back. He will return to the classroom next Wednesday. If you know him please stop by and say hello.
- 3.4 **Flora** announced that staff and faculty senates have each been given 20 tickets for the football game on November 16. Please email Hendrix if you would like tickets.
- 3.5 Lyons noted that an interesting show about the college admissions scandal was on CNN last night.

4. Presentation

- 4.1 Andrew Worley, Emergency Management Specialist Safety Discussion and Questions
 - 4.1.1 The Stay Safe on Campus website (https://www.etsu.edu/safety/) has information for how to react in several different types of emergency situations. If you have safety questions this is a great resource to start with.
 - 4.1.2 Everyone should have the 24-hr dispatch number (9-4480) programmed into their phone. This is the best way to reach help in an emergency situation. This is preferable over 911 because it is where a 911 call will be transferred to and using dispatch can save time. Emergency phones are located around campus at the red poles or yellow boxes.
 - 4.1.3 Locks are being updated across campus and installed where locks did not already exist. Many classrooms now have locks and this provides additional options for personal safety.
 - 4.1.4 The security camera project has been delayed because the vendor went out of business. The university has a grant to replace all cameras on campus and has spent 400k on the project. Despite having fewer cameras on campus, coverage has increased by 60% due to technology improvements.
 - 4.1.5 Future projects will address expanding the emergency notification system such as presenting emergency messages on monitors across campus and expanding indoor PA capabilities.
 - 4.1.6 The ETSU SAFE app is now active and should be downloaded. If the app is used for an emergency the dispatcher also gets location information, even before the phone rings so even if the call is disconnected dispatch can send someone to the location. Emergency plans are stored in the app so that you can know what to do in any type of emergency situation. Safe Walk can be used from the app and the user can choose who they would like to watch them while they traverse the campus.
 - 4.1.7 **Byington** asked how students find out about the app. **Worley** responded that it is just starting to be marketed and flyers are being handed out at open houses. Anyone can download and use the app.
 - 4.1.8 When alerts are sent they will include what is happening, where it is happening, and what actions should be taken. Subsequent messages will include updates on the situation.
 - 4.1.9 [Mr. Worley presented a safety video.] A shooter threat is very different from other threats because it is unpredictable and the appropriate action to take will not be the same in all situations. Active shooter events typically last less than five minutes. Public safety response is about two minutes and people will be on their own and need to make decisions quickly. In order, the best course of action is to run, hide, or fight.

4.2 Sarah T. Melton, PharmD, BCPP, BCACP, FASCP Professor of Pharmacy Practice Gatton College of Pharmacy at East Tennessee State University –Naloxone Training

Dr. Melton presented the Naloxone training and dispensed Naloxone to senators.
