Minutes, October 14, 2009

Since there were a number of issues that all performance proposals shared in common, it was decided by the committee to discuss these issues once:

- 1. Change Credit Hours (maximum): to NA.
- 2. Move "or permission of the instructor" from Prerequisites and add to the course description.

- 3. Do not repeat Course Title in the Course Description.
- 4. Clearly differentiate between intermediate and advanced purpose and goals (and remember that goals are the goals of the course).
- 5. Consult with Ed Kelly concerning wording in attendance, participation, and disability policies.
- 6. Create rubric to evaluate "Skill and Growth".

Deadman led the discussion on this proposal with the following recommendations made:

- 1. Scale down the language in Purpose because it sounds like a proposal for a major rather than a minor.
- 2. Add expected learning outcomes to the Purpose.
- 3. Add data about local programs (eg. UT phasing out its dance minor) in the Need section.
- 4. In Form PS: Program Structure, change Total credits required for graduation to N/A.
- 5. Removed section on Accreditation because it is not possible to have the minor accredited.
- 6. Make sure the Evaluation Plans address how to evaluate whether the goals and objectives listed under the purpose are fulfilled.
- 7. Clarify the proposal so that it is clear that courses will be offered on a 3 year rotating basis.

Page made a motion to refer the proposal back to the creator for revision and then return to committee. Seconded by Green and passed by acclaim.
