### 3. Proposals Reviewed

a. (2:05-2:25 pm) TBR Proposal: Removal of portfolio requirement for BA in Foreign Languages (Originator: Jerome Mwinyelle)

Proposal was represented by Professor Ardis Nelson, and reviewed for the committee by Debbie Dotson and Chol-Young Roh.

The following editorial changes to the proposal were identified as needed:

This is a TBR proposal to drop the portfolio requirement for foreign language French, German, and Spanish majors. Committee noted the need for clarification in the fields of "concentrations" on the form cover, to delete "French, German, and Spanish" since these are majors and not concentrations. Form summary

Reviewers for the committee also noted that under "need" in the curriculum field, the reference to the Foreign language department needs to be changed to 'foreign language faculty in the Department of Literature and Language.

Implementation date must be changed to Spring 2011.

Motion to approve pended editorial changes stipulated above: Debbie Dotson, Second Shawna Lichtenwalner, Approved by unanimous vote.

b. (2:25-2:45 pm) New Course Proposal: GEOL 3500 Volcanology (Christopher Gregg) Todd Emma & Jason Davis

Proposal was represented by Chris Gregg, and reviewed for the committee by members Emma and Davis.

Gregg emphasized the 'cache' of the study of volcanoes in the field of Geology. He noted that this course has been taught under an experimental number the maximum number of times. And he spoke of the broader implications and advantages of study volcanic hazards and risks.

Proposal: The following editorial changes to the proposal were indicated by the committee:

Maximum credit hours should be N/A. Under availability of resources, each of the fields should be "adequate".

Committee invited editing the catalog description for clarity (deleting the list of topics) and the rational for proposal to point out that the course enhances coverage of core concerns of the discipline, in line with standard practices in the discipline.

Syllabus: Committee requested revision of learning objectives.

Motion to approve pending stipulated editorial changes without returning to committee made by Green, seconded by Deadman, approved by unanimous vote.
