*Formerly section 1.14.4.3.b of the Constitution to be re-placed in the current Constitution as below:

4. ARTICLE III: MEMBERSHIP

- 4.1. Term of Office. The term of office for an elected member of the Senate shall be three (3) years with the exception that:
 - 1. The term of the president shall be automatically extended for up to three (3) years to ensure uninterrupted progression into the office of past president. At the end of this extended term of office, the affected school, college, or academic unit shall elect a senator to complete any remaining years of the normal term.
 - 2. In the event of the death or resignation of a faculty senator during the senator's elected term of office, the remaining senators of the affected school, college, or academic unit shall, at the direction of the President of the Faculty Senate, select a new representative from the affected school, college, or academic unit. The new representative is to complete the unexpired term of the vacated Senate seat.

 The selection of the new representative shall be accomplished by a majority vote of the remaining 69 senators or as specified by the constitution of the affected school, college, or academic unit.

- 5.1.1 **Dr. Bishop** discussed the possibility of ETSU to provide the first public university post-baccalaureate pre-med program. Academic Council has recently discussed the possibility. Although they have not begun to develop the program, a group should be formed to develop a proposal to present to the AC.
- 5.1.2 **Dr. Bishop** provided an update on the Mountain States Health Alliance/Wellmont Health System Merger. TN approved a Certificate Of Public Advantage (COPA) on September 19, 2017 and VA approved their Collaboration Agreement on October 30, 2017. The monetary obligations that the two health systems agreed to are as follows:

85 million for health research and graduate medical education;

75 million for population health improvement;

8 million for a region wide health information exchange;

140 million to expand access to behavioral health services, children's health services, and rural health services.

A three year plan to spend the money will be developed for each of the areas within 90 days of closure.

- 5.1.3 The non-monetary obligations are focused on the following issues:
 - 5.1.3.1 Protection of employees no hospital can be closed within five years of the merger; however, they could be repurposed, with approval, and employees will not lose jobs.
 - 5.1.3.2 Governance The board will have 11 voting members and three ex officio voting members.
- 5.1.4 ETSU has signed Memorandums of Understanding (MOUs) with MSHA and Wellmont. The health system and ETSU have the first right of refusal for any new endeavors sought by the either entity.

5.3 Repair of Constitution

8. Old Business

8.1 Senator Drinkard-Hawkshawe re-introduced the second motion that was to be discussed on October, 23. Drinkard-Hawkshawe explained that she has concerns about revising the rules and regulations governing student appeals. The rules are important for the quality of education at the university, and to protect faculty. A committee should be formed to review the rules and regulations so that it is clear as to what must be done in order for a student to protest a grade.

Motion 2 – previously submitted by Senator **Drinkard-Hawkshawe**:

Faculty Senate Committee should be organized to review the Student Grade Appeals process. A group meeting--student, faculty, Chair--should be required before a student can appeal a grade. Rationale: A student requested to meet with me, without giving a reason after I requested a reason three times via e-mail. After meeting with the student, he still did not give the reason that he gave



the Dept. Chair. He lied and filed an Appeal.

The motion was seconded by senator Al-Imad.

- 8.1.1 Discussion
- 8.1.2 Senator **Panus** inquired as to whether each college has its own process to deal with grade appeals. **Epps** responded that there is a university-wide grade appeal process.
 - 8.1.3 Senator **Foley** mentioned that faculty had expressed concerns about the requirement of having the student and faculty member meet with the department chair. One concern is that the grade was awarded maliciously and the instructor will not acknowledge it or change the grade. Another concern is that if a student was harassed by the faculty member they should not be forced to meet with the faculty member, or if a student was assigned a grade based on political affiliation, gender, religion, or other characteristic will find no recourse from meeting with the instructor.
 - 8.1.4 Senator **Lowery** added that one of her constituents suggested that grade appeals should be logged into a computerized system.
 - 8.1.5 Senator **Alsop** added that one person agreed with the motion and two others were not in support of the motion.
 - 8.1.6 Senator **Walden** asked what happens when a student bypasses the instructor and goes to the chair. **Epps** replied that the student is not required to consult with the faculty member before filing an appeal. The policy states that they should meet with the faculty member but it is not necessary.

Approved Motion in Support of DACA "Dreamers"

WHEREAS, President Trump has rescinded the Deferred Action for Childhood Arrivals (DACA) program protecting the hundreds of thousands of young immigrants brought into this country as children, commonly referred to as "dreamers;" and

WHEREAS this policy shift directly impacts some of our students who are remarkable men and women making significant contributions to our campus, our community and our country: Now, therefore,

BE IT RESOLVED, the University of Memphis Faculty Senate this third day of October, 2017, supports and encourages the university to make all efforts possible working with other universities and our elected representatives to ensure that DACA "dreamers" can remain on our campus and in our country.

Presidential Grant-in-Aid

Presidential Grants-in-Aid (PGIAs) are funded annually in East Tennessee State University's budget. PGIAs are administered by a committee composed of representatives from each college/school, who are nominated by the respective deans and appointed by the Provost or a designee. The Provost or a designee also appoints the committee chair. The committee issues requests for PGIA applications, reviews applications, and submits recommendations for awards to the Provost or a designee.

Policy

PGIAs support faculty development with respect to teaching, research, creative activity, and service. PGIAs may fund credit or non-credit activities in a faculty member's current specialty or discipline or in a new specialty or discipline. Support may be given for faculty to obtain a degree, certification, credentials, targeted training, or a specific skill set that enriches their professional effectiveness. Full-time, tenured, tenure-track, clinical and research faculty, and lecturers are eligible to apply for PGIAs. The maximum funding for a PGIA is \$5,000. Both individual faculty and groups of faculty, such as those in departments, colleges and schools, may apply for PGIAs. The committee gives higher priority to applications by individual faculty. Recipients of individual awards and lead applicants for awards to groups of faculty must submit a brief written report to the PGIA committee following completion of funded activity.

General Information

The sole purpose of PGIAs is to allow faculty to engage in focused, non-recurring activities designed to increase their expertise as teachers, researchers and creative artists, and providers of professional service. PGIAs do not support attending or presenting at professional meetings, but will support proposals to attend specific training workshops occurring as a part of larger professional meetings. The PGIA committee does not fund specific research projects, but it does consider funding proposals to acquire the expertise needed to conduct research (e.g., by attending workshops for that purpose). The committee does not fund activities required to renew certifications, credentials or licensure, but it does consider proposals to obtain new certifications, credentials or licensure. The committee welcomes proposals to foster a faculty member's excellence in teaching. However, it does not fund proposals to redesign courses, purchase equipment, or support instruction in specific courses; faculty should submit such proposals to the Instructional Development Committee.

The PGIA committee scores applications by evaluating their potential to enhance the applicant's ability to conduct teaching, research or creative activity, or service; it funds proposals based on these scores. There are no restrictions on the number of awards an individual or group may receive over the years. However, if funds are not available to meet all requests and all other factors are equal, the committee gives preference to applicants who have not received awards previously.

Procedure for Submitting Applications

Complete the Presidential Grant-in-Aid form, available online in Microsoft Word format, and email as noted: http://www.etsu.edu/senate/facultyhandbook/forms.aspx

Supporting material should be provided as a link in the document, an inserted image, or a separate scanned file. Applicant, Chair, and Dean signatures are not required at the time of submission but will be needed before funds are released. However, the applicant may solicit positive comments from the Chair or Dean prior to review by the Committee.

Grant Administration Procedures

Following are the deadline months and the activity period for the deadlines. A specific deadline date within these months will be determined by the Committee Chair and distributed as a reminder to all faculty through the e-mail system.

May, for activity period July – September September, for activity period October – December November, for activity period January – March February, for activity period April – June

Funding Procedures

All awards will be made through existing ETSU processes (e.g., travel, supplies, honorarium, etc.) Awards normally must be expended or, where permitted, encumbered by the end of the fiscal year (June 30). If an activity extends into a new fiscal year, the applicant(s) must divide the proposed budget to show which expenditures will fall into each fiscal year.
