Dr. Bach asked for a proposal from Dr. Brown to establish a new Center for Faculty Excellence. The proposal is being drafted and the center is expected to be established as soon as Fall 2016.

Faculty senate would like to host a monthly gathering for new faculty – Dr. Foley asked for volunteers to lead sessions.

Dr. Foley asked that senators from each college discuss how to disseminate information to their constituents (during lunch break).

Welcome and updates from ETSU Senior Administrative Staff: Drs. Bach, Bishop, Sherlin, Collins, and Ms. Ritter

Summer School Update – Dr. Foley

Eleven faculty chose to participate in the pilot program to teach for reduced pay. In the Executive Committee meeting with Dr. Noland, he stated that the faculty members salary would be made whole.

Enrollment Background – Mike Hoff

Undergraduate enrollment is down, graduate enrollment is up. Nonetheless, undergraduate FTE's are up; therefore, students are taking more hours than in previous years.

TBR wants to move students toward a specific major early in the undergraduate curriculum to bolster degree completion in four years.

In state enrollment will go down this year; however, out of state and border county enrollment will increase.

Faculty to student ratio has remained stable ~ 20 on average.

First time freshman retention rate is 66%, transfer student retention rate is 75%.

Fall 2015 projections from 2014 was 13,566 – now we should be slightly higher (within 1 or 2 percent).

SAI Committee Report – Kathryn Sharp; Leigh Lewis

The transition to online SAI reporting resulted in a response rate decline.

The new questionnaire separates the items into categories; online, classroom, and lab, to make them more applicable to all settings.

The student feedback questions have been expanded to include self-evaluation because research shows that when students evaluate themselves first they are more likely to accurately evaluate instructors.

The new system will allow instructors to choose a defined number of questions from a larger bank of questions to allow the instructor to define the most relevant evaluation areas for a specific course.

Dr. Foley asked for suggested changes to the SAI to be sent to Dr. Epps. Dr Epps will not implement the current questions until a revision has been made and the questions have been approved by the Senate.
