The subcommittee met 5/24/04. Percentages of permanent, part-time staff workers were reviewed based upon the following data provided by Human Resources.



Category 1	59	2	61	3%
Category 3	549	11	560	2%
Category 4	575	125	700	18%
Category 5	75	14	89	16%

Category 7	201	6	207	3%

Given the total of 1530 total permanent full-time staff members and 159 total permanent, part-time staff members, it was calculated that only about 9% of the permanent staff members at ETSU are in the part-time category. The subcommittee further decided that the current EEOC categories sufficiently represent all staff members. The subcommittee decided that a separate category for permanent, part-time staff is not warranted.

Per directions from the Senate, the Staff Concerns & Grievances Committee met to further discuss the issue of membership eligibility for permanent, part-time staff members and their eligibility as potential nominees for the Distinguished Staff Awards (DSA).

Committee members were provided with additional data showing that 9% of ETSU permanent staff members are currently part-time employees. In certain specific EEOC categories the percentage of permanent, part-time staff is even higher, 18% in Category 4, and 16% in Category 5.

Distinguished Staff Awards (DSA) As to the eligibility of permanent, part-time staff members as potential nominees for the DSA, the committee stands with the recommendation made in the Senate on April 11, 2005. Following is the background information and re-tendered recommendation:

Research of the Archives of Appalachia documented that the DSAs were first awarded in April of 1983 under the ETSU Presidency of Dr. Ronald Beller. Staff Senate minutes (1978-1985) made no distinction between full or part-time employee eligibility for the DSAs. Currently, according to our foundation accounting office, "Staff awards are given to full time employees at the discretion of staff awards committee." Since DSA eligibility rests within the purview of the Staff Senate and through it, the Staff Awards Committee; and since DSA eligibility is not mandated in the Staff Senate Constitution or Bylaws, but rather by Staff Senate vote, after careful discussion, the committee decided upon the following recommendation:

Recommend that eligibility for Distinguished Staff Awards be open to all permanent staff members regardless of full or part-time status.

<u>Staff Senate Membership Eligibility</u>: Membership eligibility changes fall under the Staff Senate Constitution, Article III, Membership, Section A., Eligibility. Constitutionally, Senate membership eligibility is open to, "Any full-time member of the university staff....." Research through the archives uncovered at least one precedent. Sue Ann Reese, who was a part-time employee at 80% employment, served as a Staff Senator (Category 5) from 1996-1998, and was an active and productive senator as reflected in the archives of the senate minutes. Statistics provided by the ETSU Office of Human Resources indicates that 9% of ETSU employees are currently employed at permanent, part-time status. Further discussion among the committee revealed the deep commitment to ETSU exhibited by many part-time employees, some of whom have been employed at part-time status for over ten years.

The committee re-considered the original recommendation made in the Senate on April 11, 2005 and decided that the issue of making the amendment retroactive to the last election has become moot, since Senate elections will be held early in the upcoming fall semester. Therefore, the Staff Concerns & Grievances Committee sends this revised recommendation to the Senate:

Recommend that the Staff Senate Constitution, Article III, Membership, Section A., Eligibility, be amended to encompass permanent part-time employees of ETSU; that if the amendment is adopted by the Senate, nomination forms and election materials be so edited.

Following is Article, III Membership, A. Eligibility, currently in place in the Staff Senate Constitution along with the highlighted recommended changes in text.

ARTICLE III MEMBERSHIP

The Staff Senate shall consist of thirty (30) elected members.

• A. Eligibility: Any *permanent* full *or part* -time member of the university staff (non-faculty component) having been employed by the University for a period of not less than one (1) year shall be eligible for election to membership. The university staff is defined as all nonacademic, non-teaching personnel employed by the University. University administrative and support personnel holding academic rank but not eligible for representation by the Faculty Senate shall be eligible for election to membership in this body.
