The UCC meeting was called to order at 3 p.m. by Chair Keith Green after a meeting from 2 - 3 pm with college curriculum committee chairs led by Dr. Grube.

Old Business

Aruna Kilaru moved to approve the April 27, 2016 minutes and was seconded by Shirley Cherry. The motion passed unanimously with one abstention. (Theresa McGarry was not a committee member in April.)

New Business

Volunteer to attend Academic Council Meetings (Fall Semester, 2016)

Suzanne Smith volunteered to attend Academic Council meetings at 8:15 am on the 2nd and 4th Thursdays of the month. She will be responsible for:

- introducing any proposals brought forward from the UCC then motioning for approval.
- reporting back to the committee actions taken at Academic Council.

— Non-substantive Curriculum Change: Communication Studies Major (Arts and Sciences)

Wesley Buerkle provided an overview of the proposal. Students transferring to ETSU from other colleges are losing 3 credits in the transfer process. This proposal would allow transfer students 9 credit hours at the 1000/2000 level rather than 6 credit hours which in turn would allow them to count all credits

when transferring to ETSU. There are no new or modified courses associated with this proposal.

Recommendations:

Suzanne Smith moved to accept the proposal pending the requested editorial change related to AS. The proposal is to be returned to the UCC Chair for final approval. Aruna Kilaru seconded. The motion passed unanimously.

Wesley Buerkle provided an overview of the proposal change for the minor. There are 21 hours in the minor. With this change, 9 of 21 credit hours will be at the 3000/4000 level. Policy related to designation of a minor specifies a minimum of 18 credit hours with 9 at the 3000/4000 level.

Ruth Facun-Granadozo provided an overview of the proposal. The proposal would replace CUAI 4517 (Math Methods for Early Childhood) with ECED 4451 (Foundations of Mathematics Instruction & Assessment for Pre-K-3).

Recommendations:

- Rationale for Proposal Revise to explain how changing from CUAI 4517 to ECED 4451 better aligns with curriculum goals or how this change will strengthen/improve the curriculum.
- Summary of Actions Remove the final two sentences beginning with "Note:" and ending with "this course."

• List Newly created ETSU courses for this curriculum change: Remove ECED 4551 and put N/A

Other Actions:

- Billie Lancaster will verify the correct degree and concentration names that should appear on this proposal. She will e-mail Lynda Sharp with this information.
- Keith Green will request a letter from Karin Keith, Department of Curriculum and Instruction, verifying she is aware of the proposed change.

Suzanne Smith motioned to return the proposal for the recommended changes. The proposal will then return to the committee for final approval. Theresa McGarry seconded. The motion passed unanimously.

Hi Kathryn,

Is an email statement (like the one below) sufficient or do you need a formal letter? Please let me know if this is what the committee was looking for. I do not have much experience with their expectations.

To members of the undergraduate committee:

Dr. Kathryn Sharp, as the undergraduate program coordinator for PreK-3 in the Department of Teaching and Learning, has shared with me the desire (and proposed syllabus) to create a new course, *ECED 4451 Principles of Differentiated Mathematics Instruction and Assessment for PreK-3*, to be included in a program of study specific to Early Childhood. Although I have received feedback from some faculty that are concerend it will have a strong impact on the enrollment of our current content methods-based course (offered as part of the current PreK-3 program and sometimes take by CUAI students), *CUAI 4517/5517 Mathematics for Early Childhood*, I am aware and understanding of the rational that the Department of Early Childhood seeks to pursue this new course proposal. I have spoken with their chair, Dr. Evanshen about the concerns earlier in the semester. Overall, I do not oppose their seeking approval of this course proposal that is tailored to the mission and vision of their department as early childhood specialists. Perhaps there will be opportunities for our future students (and possibly graduate students, if it is dually listed) to participate in the course in the future.
