I. Non-Substantive Curriculum Change: Rural Health Graduate Certificate (Dr. Jodi Southerland)

- a. Name changes go on different form and this has faster approval. Question is do you want to change the name now or after the curriculum changes?
- b. Certificates by definition are very prescribed. This means all courses are required or, sometimes, one elective. Changing two of the five required courses to be either/or is not in keeping with best practice. Question is what do you want certificate to be? If Community Health, then make those courses the required ones.
- c. If the certificate will be marketed as all online, then why include the rural health courses?

- d. Does the program want to keep the articulation language? If so, and if the certificate name is going to change, then this edited sentence should also be included?
- e. Clarify what want the certificate to be branded as.....
- f. Start date for curriculum change needs to be fall 2017

This proposal was tabled until August at the proposer's request.

- a. Page 1 Purpose suggest "in program content by increasing standard for progression through the program."
- b. Accreditation section if this is an MSN, why the sentence on ETSU's DNP accreditation?
- c. Throughout: should RODP be changed to ROCC or TN eCampus?
- d. Last page: rationale should not be on the side-by-side. This should go in Rationale. The side-by-side section should only have what needs to go into the catalog

Students were having trouble passing the nursing license test after graduating. A proposal was made to have students repeat after their first "C" grade. After their second "C" the student would be dismissed.
