The meeting was called to order by President Wanda Richardson at 2:30 p.m.

MINUTES: Senator Proffitt made the motion to approve the minutes of June 8, 2009. Motion seconded by Senator Dills. The minutes were approved as distributed.

TREASURER'S REPORT: Senator Canter reported an ending balance of \$4,425.76 for the fiscal year 2008-09. The 2009-2010 budget has been set at \$6,000.

COMMITTEE REPORTS:

- Staff Development and Evaluations: No report.
- Committee on Committees: No report.
- Staff Concerns and Grievances: No report.
- Elections Committee: To date, there have been 35 nominations for membership and 2 unsigned requests. There have been no nominations from category 6 and 7. Paper nomination letters were sent to all Physical Plant employees. President Richardson urged all senators to speak with individuals in their buildings that may be in EEOC categories 6 and 7, and encourage them to nominate themselves for a Staff Senate position Paper election ballots will be sent to Physical Plant again this year and everyone else will be voting online. - Holiday Food Drive Committee: No report.
- Staff Picnic Committee: Senator Bond reported that all 69 vendors who supplied door prizes have been formally recognized for their generous donations. A letter of

appreciation has also been sent to Dr. Richard Manahan and the Office of University Advancement for their continuous support in funding the Distinguished Staff Awards.

OPEN FLOOR FOR NEW AGENDA ITEMS:

It could be a valuable tool in recruiting members and in particular new employees joining the ETSU workforce. Senators Murphy, Nave, Blackburn, Starnes, Sullivan, and Jones will make up the taskforce.

Proposed Bylaws Changes - June 2009

Change Article I, Section B

DELETE this section

Except for the Executive Committee, the size of committees shall be limited to four (4) duly elected Senators appointed by the President. The Chair shall be appointed by the President at the same time.

AND REPLACE with

The number of Senators on each committee may vary according to the complexity of their tasks; such number to be set prior to the October meeting by the Executive Committee. Senators may volunteer to serve on committees of their preference; however, any senator having not expressed a preference may be assigned to a committee by the President. The chair of each committee shall be appointed by the President by the October meeting.

ADD to the listing of standing committees

The Communications and Website Committee

ADD to Article I, Section C

5. Communications and Website Committee. The committee shall be charged with the following responsibilities:

1. Maintaining the Staff Senate website with current activities, updated rosters, and current photographs.

2. Utilizing various means of communication (campus email, Accent - the campus newsletter, University Relations staff, etc.) to inform the campus and local communities of Staff Senate activities, elections, and other appropriate news items concerning the Senate.

3. The chair of this committee shall be listed as the web manager for the Staff Senate's website and shall serve as the primary point of contact for those interested in the Senate's activities.
