#### **Graduate Council Annual Report**

#### 2016 - 2017

The Graduate Council convened monthly from August through November in 2016, and January through May in 2017. In addition to the monthly Graduate Council meetings, members also served on either the Graduate Curriculum Subcommittee or the Graduate Faculty Subcommittee. The Council's voting members included elected faculty representatives from the nine academic units that offer graduate programs, the Sherrod Library, the Faculty Senate, two representatives from the Graduate and Professional Student Association, and three additional at-large individuals representing graduate education.

The Graduate Council is charged with the appointment of graduate faculty, all graduate curriculum matters, and the formulation of policies relating to graduate education. The Council reviewed and approved 20 new graduate faculty appointments and 90 graduate faculty reappointments. Related to curriculum proposals, the Graduate Council approved 28 new courses, 15 new graduate program proposals, 11 curriculum revisions, and six course modifications. Two graduate education policies were revised; these included a revision of the Graduate Council charge to clarify that the Council receives reports of graduate accreditation and graduate program reviews, and a revision of the Dual Degree Admission policy to allow students to seek admission simultaneously to a master's and doctoral program.
