-Substantive Revision of a Degree: B.A. Theatre

Karen Brewster provided an overview of the proposal which revises the degree to include a common core with four concentrations: Acting, Design/Production, Musical Theatre, and Physical Theatre.

- Current and Proposed Program of Study Add this sentence below the table: The Dance Minor is required for the concentrations in Musical Theatre and Physical Theatre. (done)
- New Course Information change catalog descriptions to match the edits made in today's meeting (done)

- Grading Scale C + add "and"; F (below 60) (done)
- Attendance Policy edit d2l to D2L (done)
- Academic Misconduct move last sentence to beginning; eliminate everything else (done)
- Other add syllabus attachment (done)

Tabitha Fair motioned to approve the proposal with the edits completed during the meeting. Tony Pittarese seconded. The motion passed unanimously.

Melissa Shafer motioned to approve the proposal with the edits completed during the meeting. Tony Pittarese seconded. The motion passed unanimously.

-Non-Substantive Curriculum or Minor Revision – Legal Studies Minor
Colin Glennon provided an overview of the proposal which changes PHIL 3150
Philosophy of Law from an elective to a required course which better meets student need and is more in line with degree programs at other institutions.

Recommendations:

Number of Courses Modified – change to 0 (done)

- Current Program of Study does not match what is in the catalog; copy and paste information from catalog (done)
- Program Revision and Final Revision need to be corrected based on information copied into Current Program of Study box

Dr. Glennon and/or Dr. Battista were asked to meet with Dr. Grube to correct the Program Revision and Final Revision sections of the proposal.

Scott Koterbay motioned to accept the proposal pending the correction of the Program Revision and Final Revision sections by Drs. Glennon/Battista and Dr. Grube. The proposal will return to the chair for approval. Kim Sell seconded. The motion passed unanimously.

Other Discussion

Shirley Cherry reviewed the UCC meeting dates for spring semester: January 9 and 23, February 13 and 27, March 27, and April 10 and 24. These dates are posted on the Curriculum Process website.
