In compliance with the Tennessee Tuition Transparency and Accountability Act (Tennessee Code Annotated § 49-7-1603), the ETSU Board of Trustees is providing notice of the proposed tuition and mandatory fee increase as an action item on the Board’s meeting to be held in June 2019.
