D. Graduate Education Policies

I. Application for Admission to a Doctoral Program Policy, Optional GRE - Brian Johnston

Dr. Johnston asked the council if the GRE score requirement for doctoral programs could be moved from the graduate level to the department level. Masters's programs are already at the department level. This would allow each doctoral program to consider whether to incorporate the use of GRE scores in admission decisions at the program level as appropriate. Several points were brought up about this proposal such as the GRE is not a good predictor of success; many schools are looking at doing away with the GRE score requirement for doctoral programs. Dr. Grube suggested that if council approves, Dr. McGee should write the proposal.

Caleb Bennett talked about the trip in Dr. McGee's absence. They traveled to 8 different cities and met with faculty and students from various universities.
