Jason Davis moved to approve the December 9, 2020 minutes. Scott Koterbay seconded. The motion passed unanimously.

#### **New Business**

## -New Course CHNG 1008 - Johnson City: From Exploration to Impact

Karen Kornweibel provided an overview of the proposed course which will be part of the new changemaking minor. This course provides students with structured explorations of Johnson City.

Prior to the meeting, Primary Reviewers Julie Bowers and Dana Harrison contacted Karen Kornweibel to clarify information related to Academic & Credit Number Justification and Major Assignments. With input from the originator, edits were completed in these areas prior to the meeting.

### -New Course CHNG 1908 - Introduction to Changemaking and Social Innovation

Karen Kornweibel provided an overview of the proposed course which introduces students to changemaking and social intervention and links them to changemakers in the community.

Primary Reviewers Julie Bowers and Dana Harrison found the proposal to be well written with no areas of concern.

### -New Course CHNG 4908 - Changemaker Scholars Capstone

Karen Kornweibel provided an overview of the proposed course in which students apply content from CHNG 1008 and 1908. In the capstone, students develop an action plan then form a community partnership to implement the change.

Prior to the meeting, Primary Reviewers Jason Davis and Scott Kotterbay contacted Karen Kornweibel to clarify information related to the Catalog Description, Course Topics, Course Repeatable for Credit, Learning Outcomes, Required Texts/Readings, and Attendance Policy. With input from the originator, edits were made to the course topics and learning outcome #2.

During the meeting, Dr. Kornweibel clarified the 3-hour course may be repeated 1 time for a total of 6 credits. The course is designed in this manner to accommodate larger, more involved change projects. Depending on the extent of the project, some students may take a 3-credit internship and the 3-credit capstone courses while others will repeat the capstone for 6 credits.

#### -New Course UHON 3908 - Honors Internship

Karen Kornweibel provided an overview of the proposed course which will be part of the changemaking minor. The course is needed to provide an internship opportunity for the minor and for other programs within the Honors College.

Prior to the meeting, Primary Reviewers Jason Davis and Scott Kotterbay contacted Karen Kornweibel to clarify information related to the Catalog Description and Course Repeatable for Credit.

During the meeting, Dr. Kornweibel clarified the course credit range of 1 to 4 was intentional to allow flexibility because internship experiences vary according to program expectations within the college. The number of credits awarded for the internship is based on hours of contact. In terms of repeatability, the intent is for students taking a 4-credit internship to be able to repeat the course one time for a total of 8 credits. Determining credit hours and repeatability is regulated through advisement before students are permitted into the course.

#### - Establish Minor - Changemaking Minor

Karen Kornweibel provided an overview of the proposed minor which includes the courses approved in today's meeting and courses offered in other departments (SRVL 1020 Introduction to Service Learning and TECW 4200 Grant Writing). There is also an option for UHON 4808 Honors Study Abroad as a guided elective.

Primary Reviewers Tabitha Fair and Julie Fox-Horton found the proposal to be well written and an exciting option for students to pursue.

With input from the originator, the following edits were completed during the meeting:

- Number of New Courses change to 4 (done)
- Number of New Credits change to 12 (done)
- This minor is restricted to students in the Honors College. Dr. Kornweibel will e-mail either Evelyn Roach or Casey Gardner to request this stipulation be added to the proposal.

## -New Course CUAI 3010 - Language and Culture in PreK-12 Classrooms

Natalia Ward provided an overview of the proposed course which is the first in a sequence for the proposed English as a Second Language minor. In this course, students learn about the foundations of language and develop cross cultural awareness to support teaching English language to children.

Primary Reviewers Tabitha Fair and Julie Fox-Horton found the proposal to be well written with only 1 minor typo which was corrected prior to the meeting with the originator's approval.

Prior to the meeting, Primary Reviewers Melissa Shafer and Jonathan Taylor contacted Natalia Ward to clarify information related to the lack of prerequisite courses and a typo in the Assignments. With input from the originator, the typo was corrected, and it was confirmed prerequisites were not required for the course.

Students design evidence-based teaching plans and prepare to be decision makers in the classroom.

Prior to the meeting, Primary Reviewers Melissa Shafer and Jonathan Taylor contacted Natalia Ward to clarify information related to the lack of prerequisites. With input from the originator, the it was confirmed prerequisites were not required for the course.

Prior to the meeting, Primary Reviewers Melissa Shafer and Jonathan Taylor contacted Natalia Ward to clarify information related to the lack of prerequisites. With input from the originator, the it was confirmed prerequisites were not required for the course.

Prior to the meeting, Primary Reviewers Sookhyun Kim and Jennifer Young contacted Karen Keith to clarify information related to the Title of the Minor, Academic Justification, and New Course Information.

  - Sentence 3 adjust to read "Rather it may lead to a license. . ." (done)
  - Sentence 5 Add minor after Secondary Education; delete what follows double minor (done)
- Program of Study add a line to table then add "Other language classes may be accepted upon approval of the program coordinator." (done)
- Number of Existing Courses change to 15 (done)
- Number of Existing Credits change to 45 (done)

 New Course Information – change the title of CUAI 4017 to ESL Teaching Methods and Materials in Pre-K-12 Classrooms (done)

- Revise Course: Substantial Modification NRSE 2351 - Patient Centered Care I Practicum Michelle Littleton provided an overview of the proposed course revision in which medication administration content will be moved from the first semester clinical course into the second semester clinical course. With shifting of this content, the credits for NRSE 2351 is decreased from 4 to 3 and the credits for NRSE 3501 is increased from 3 to 4.

Prior to the meeting, Primary Reviewers Sookhyun Kim and Jennifer Young contacted Michelle Littleton to clarify information related to movement of content and credits between the courses.

Prior to the meeting, Primary Reviewers Laurie Schroder contacted Melessia Webb to correct one typo.

# - Revise Program Policy - Nursing BSN - Progression

Beth Thompson provided an overview of the proposed progression revision which is in response to changing NRSE 4300 Skills Validation to 4 level specific courses: NRSE 4301 Skills Validation 1, NRSE 4302 Skills Validation 2, NRSE 4303 Skills Validation 3, and NRSE 4304 Skills Validation 4. Under the current policy, students not enrolled in a clinical course for more than two semesters are required to take NRSE 4300. This proposal decreases the time the student can be out of a clinical course from 2 semesters to 1 semester and replaces NRSE 4300 with the level appropriate skills validation course.

Primary Reviewer Laurie Schroder reviewed the proposal and had no areas of concern.

During the meeting, Dr. Thompson realized the designation for how long a student may be out of the program before taking the skills validation course is contained in a separate policy. The proposal was adjusted to remove the change related to time out of the program. Dr. Thompson will bring this change forward as a separate proposal.

With input from the originator, the following edits were completed during the meeting:

- Academic Justification
  - o Begin the first paragraph with "The course . . ." (done)
  - Delete paragraph 2 (done)
