-New Course CDST - 4317/5317 - Applied and Professional Ethics
Allen Coates provided an overview of the proposed course.

Prior to the meeting, Primary Reviewers Jennifer Young and Scott Contreras-Koterbay contacted Allen Coates to clarify information related to the lack of prerequisite courses, attendance policy, and potential overlap in content with PHIL 5017 Ethical Theory and MGMT 5020 Legal and Ethical Responsibility.
