There will no longer be a paper Program of Study. Degree Works replaces this form. Evelyn is working on any holds or provisions for a student that can go to Degree Works. PhD's still must have a candidacy form. Substitution form was discussed. A course substitution form must be filed by the eighth day of the semester. After the eighth day, the course substitution will not be eligible for federal financial aid, but the substitution will still be applied to the Program of Study.
