D. Graduate Education Policies

1. Pass/Fail Grading Option for Graduate Courses

A category was added to the current policy. The letter grades of

"P" (Pass) and "F" (Fail) may be used for specialized courses. Only

courses that have been approved for "P/F" grading option in the

curriculum approval process may use a P/F grading option. Graduate

students may not elect to take a standard letter grade course as P/F.

A "P" is awarded for work that is equivalent to a "C" or higher. P/F graded courses will be counted as degree credit hours earned. Failing grades (F) are computed in the student's GPA. Pass grades (P) are not computed in the GPA.

2. Graduate Admissions—policy revised and put into new template.

This policy was approved with a few changes. It will go out for public approval for a period of two weeks.

- 3. Graduate Student Retention—policy revised and put into new template. *This policy was approved with a few changes.*
- 4. Graduate Degree Requirements—policy revised and put into new template. *This policy was approved*
- 5. Determining GPA: Graduate—policy revised based on adding P/F option *This policy was approved with two revisions*
- 6. Academic Fresh Start: Graduate (currently part of Admissions policy but should be separated into its own policy)

This policy was approved.

- 7. Accelerated Bachelor's to Master's policy (currently part of Admissions policy but should be separated into its own policy)

- b. Action Item: Establishment of Consent Agenda process for select curriculum proposals (e.g., eliminating GRE in masters programs, non-substantive program revision to clarify credits for federal financial aid)

The Consent Agenda would be for those in attendance at the curriculum subcommittee that had proposals. This would eliminate those people from coming to Graduate Council since they have already presented their proposals. This policy will be decided on in the curriculum subcommittee. They would follow the same rules as Academic Council.
