Undergraduate Curriculum Committee Meeting Notes January 26, 2022

The UCC meeting was called to order at 2 p.m. by Jason Davis. The meeting was conducted virtually using Zoom. Roll was taken by Rhonda Brodrick.

Old Business:

Laurie Schroder moved to approve the January 12, 2022 minutes. LeAnn Olson seconded. The motion passed unanimously.

- Revise Academic Minor - Minor in Communication Studies

This proposal was tabled at the 1/12/22 meeting to allow the originator time to review feedback from the primary reviewers. The proposal is designed to align the minor with revisions made to the major and to incorporate learning outcomes recommended by the National Communication Association (NCA).

Primary Reviewers Laurie Schroder and Sookhyun Kim reviewed the proposal. Dr. Kim collaborated with Dr. Buerkle to discuss revisions. Prior to the meeting, revisions were made these sections: Current Program of Study, Summary of Revision, Impact of Revision, and Justification of Revision.

-New Course ETSU 1011 Introduction to the University

This proposal was tabled at the 1/12/22 meeting to allow Bill Kirkwood an opportunity to address questions from UCC members. Dr. Kirkwood explained this course was developed primarily to increase enrollment in first year experience (FYE) courses. Several FYE courses are available at the university and college levels. This course would provide an option for students unable to afford a 3-credit course. This course could not substitute for a major-specific FYE course. If approved, this course would also be used to satisfy the 1 credit college course included in the recruitment partnership between ETSU and Elizabethton High School.

-New Course NTFD 4426 Clinical Nutrition 1 Lab -New Course NTFD 4436 Clinical Nutrition 2 Lab

Michelle Lee provided an overview of the two proposed courses which support the revision of the nutrition curriculum proposal discussed at the 1/12/22 meeting. These courses are designed to strengthen students' critical thinking skills and meet accrediting body standards.

During the meeting, the following edits were completed in both proposals.

- Required texts information edited to reflect current editions, ISBNs

-New Course EPID 3040 Evidence-Based Analytics in Public Health

Michael McKamey provided an overview of the proposed course which was created by the Department of Biostatistics & Epidemiology for the College of Public Health. The course is

designed to provide students with a foundation in biostatistics and epidemiology that will allow them to interpret the validity of published work in the field. The course is needed to meet the accreditation standards of the Council on Education for Public Health.

Prior to the meeting, primary reviewers Jonathon Taylor and LeAnn Olson contacted Michael McKamey to clarify information related to whether the course is required for the major. The justification was edited to reflect the course is not needed for the major in the department developing the course; the course is required for the major in the College of Public Health.

Aimee Rowe provided an overview of the proposed revision which will exchange EPID 3080 Principles of Epidemiology for EPID 3040 Evidence-Based Analytics in Public Health.

Primary Reviewers Tabitha Fair and Jill LeRoy-Frazier found the proposal to be clear; they had no questions or concerns.
