CALL TO ORDER:

With a quorum present, President Patrick called the meeting to order at 2:50 pm.

APPROVAL OF MINUTES:

The minutes of the December 6, 1999 meeting were unanimously approved.

OLD BUSINESS:

NEW BUSINESS:

- Safe Zone Orientation. Dr. Patricia Robertson presented information regarding the Safe (Staff and Faculty for Equality) Zone program. Faculty wishing to participate in Safe Zone are identified by a sticker placed on their office doors and students with concerns or issues based on transsexual, homosexual or bisexual themes can raise them with participating faculty in a nonthreatening environment. Dr. Robertson stated that ninety faculty and staff currently participate in Safe Zone. (For more information, contact Dr. Patricia Robertson at x9-7693).
- Open Discussion and Forum on Performance Funding. Dr. Cynthia Burnley distributed and discussed the Performance Funding Annual Report for 1998-99. She summarized the standards measured for calculating scores, including general education outcomes and pilot evaluations (CBASE scores), accreditation of academic programs, program reviews (overall, undergraduate and graduate), major field assessment, enrolled student survey, retention/persistence goals, and institutional and state strategic plan goals. Dr. Burnley discussed ETSU's score for each standard and reported that ETSU scored 94 points out of 100 maximum points available. The report generated inquiries and discussion among senators regarding the financial impact of the score and several suggestions were raised about methods to increase the

score, most notably in terms of improving student commitment to better performance on CBASE. (For more information, contact Dr. Cynthia Burnley x9-7484).

ANNOUNCEMENTS:

- Dr. Bill Fisher distributed and discussed a handout of an article appearing in the December 17, 1999 issue of *The Chronicle of Higher Education* showing the percentage increases in state support for higher education across the Nation. The handout included a breakout of state spending increases for Tennessee institutions.
- Dr. Bill Fisher announced that there may be a move to combine efforts of the
 University of Tennessee and ETSU faculty in terms of benefits and compensation.
 Dr. Fisher has been extended an invitation to attend the meetings of the University of
 Tennessee Faculty Senate Benefits Committee meeting. He distributed a handout
 which included a letter from President Patrick to the President of the UT Faculty
 Senate inviting a joint meeting of the executive committees to identify issues
 concerning higher education and discuss possible solutions to the problems.
- Dr. Bill Fisher announced that TBR will soon vote on two modifications to TBR policy. He distributed a handout of a letter and attachment from Vice-Chancellor Sidney A. McPhee detailing the proposed modifications. The first modification seeks to expand the application of the existing "Clinical-track Appointments," (III.D.5) presently restricted to use at the medical school, to all nursing, health sciences, and law programs. The second proposal adds a new, sixth appointment category "Clinical Practice/Research Appointments" which will be a regular, non-tenure track appointment which could be used only at the medical college.
- Dr. Rich Ranker distributed the Spring schedule for the Academic Technology Lab.
 He also announced that the new multimedia classroom in Sam Wilson Hall is now
 operating.
- President Patrick announced that he and Dr. Norma McRae met with Dr. Toye,
 President of the Faculty Council at Northeast State Technical Community College, to
 discuss joint programs dealing with faculty development. The TLC has agreed to
 provide Northeast State with announcements of faculty development programs from
 that office.

The meeting was adjourned at 4:04 p.m. at which time standing committees met.
