-New Course ARTH 4147/5147 The Monument in History

Michael Fowler authored the proposed course which fills a gap in the curriculum related to monuments as global and historical phenomenon. In the future, the course could also be added as an appropriate elective for the certificate in Heritage Interpretation and Museum Studies.

Prior to the meeting, UCC Members contacted Michael Fowler to clarify information related to the grading scale. Edits to the B- and C+ ranges were completed.
