#### **New Business**

# -Establish New Certificate 9-23 credits – C3 Undergraduate Certificate in Brewing and Distillation Studies

Jill LeRoy-Frazier provided an overview of the proposed certificate which provides a way for members of the community to take courses in brewing and distillation without having to pursue a bachelor's degree.

Prior to the meeting, all members were asked to review the proposal. Jill LeRoy-Frazier was contacted to clarify the number of hours required for a certificate. Dr. Flora explained the minimum number of hours for a certificate was lowered from 12 to 9 by Academic Council.

- The committee discussed changing the name of the committee to Undergraduate Curriculum Council and expanding the charge of the committee to include review of policy related to undergraduate education.
- Jason Davis will work with William Flora to change the name and charge of the committee. This document will be sent to committee members prior to the end of the semester for review and approval. Once approved, it will go to the Provost for approval.
