**New Business**

***-Revise Course: Substantial Modification DHYG 4210 Building Evidence-based Practice in Dental Hygiene (formerly Clinical Seminar IV)***

Tabitha Fair provided an overview of the course revision which is proposed in response to a recommendation from the accrediting body for Dental Hygiene. In the revised course, students will review statistical cases and peer reviewed literature.

During the meeting, the Modified Catalog Description was edited to read "Selection and critical analysis of . . . "

***New Course: SOWK 4368 Substance Use and Addiction***

Dorothy Greene provided an overview of the new course which is proposed to separate a currently dual listed course into distinct undergraduate and graduate courses with different purposes. The new undergraduate course will an interdisciplinary course focused on addiction.
