### CALL TO ORDER:

With a quorum present, President Steadman called the meeting to order at 2:48 p.m.

### **APPROVAL OF MINUTES:**

The minutes of the August 28, 2000 meeting were unanimously approved.

### **OLD BUSINESS:**

- Committee Assignments. Steadman discussed committee assignments.
- Treasurer's Report. Kerley delivered the Treasurer's report.

#### **NEW BUSINESS:**

- ETSU Athletics. Todd Stansbury, ETSU's new Director of Athletics, discussed current issues in the area of intercollegiate athletics. After discussing his background, he stressed the importance of academics and indicated his support in that area. He also discussed conduct of coaches, stating that he wants to ensure that all coaches represent the university in a favorable manner.
- Performance Funding. Dr. Linda Doran and Dr. Cynthia Burnley provided a summary of performance funding results achieved at ETSU and the measures to be used over the current cycle (2000-05). They reported that ETSU realized \$2 million last year through the program and achieved an increase in total points. They addressed changes in the point distribution for the current cycle and discussed new standards and activities to be implemented as part of the program. Information was unavailable as to how ETSU

compares to other TBR institutions. (For more information, contact Dr. Linda Doran at x9-4213)

- Steadman announced that Dr. Linda Doran will address the report and recommendations from the committee on part-time faculty at the next meeting.
- Fisher announced that TCRS would be on campus October 27 for individual conference sessions and distributed a sign-up sheet.
- Fisher distributed a handout providing information about dollar amounts accumulated through fundraising at TBR institutions.
