With a quorum present, President Logan called the meeting to order at 2:49 pm.

#### APPROVAL OF MINUTES

The minutes of the October 15, 2001 meeting were unanimously approved.

- Motion to endorse the Report of the Ad Hoc Committee on Tenure Policy and Promotion Policy. Tabled until meeting on 11/19/01

#### **NEW BUSINESS:**

- Dr. Paul Stanton provided Senators with an update on the budget and its status. As of 11/5/01 the budget status is considered "marginally okay"; Commissioner of Education does not plan to recommend further impoundment from higher education. President Stanton congratulated faculty who participated on the SACS model development and reported that the Compliance Report was excellent with no area of noncompliance. He also reported that faculty and staff salary plans are on the agenda for the December THEC meeting and discussed the plans for the Armory property. He then opened the floor for questions from Senators.
- Dr. Bill Kirkwood briefly described the ETSU Quality Enhancement Plan and requested that Senators look at the QEP and provide responses by 11/15/01.

 President Logan reported on the meeting of Faculty Senate Presidents and indicated that all the Presidents felt the meeting to be productive and valuable. They agreed to meet once per semester and to work to deal with common problems.

# ALTERNATE PROPOSAL FOR A SENATE RESOLUTION REGARDING FACULTY RIGHTS AND RESPONSIBILITIES

The Faculty Senate of East Tennessee State University is aware that some colleagues in other institutions have experienced, in the wake of their public statements regarding the events of September 11, 2001, what may have been unwarranted attacks on their professional status and/or employment.

In the light of these events, the Faculty Senate reaffirms its commitment to long-standing principles of academic freedom.

These principles are clearly stated in the 1940 statement regarding faculty rights and responsibilities published by the American Association of University Professors, and are stated as University policy in Chapter Two of the East Tennessee State University "Faculty Handbook".

Therefore, be it resolved that the Faculty Senate of East Tennessee State University, by a majority vote of its members, reaffirms its support of the 1940 A.A.U.P. statement on Academic Freedom and Responsibility.
