Undergraduate Curriculum Council Meeting Notes September 25, 2024

The UCC meeting was called to order at 2 p.m. by Chelsie Dubay. The meeting was conducted virtually using Zoom. Roll was taken by Rhonda Brodrick.

Recognition of New Members and Introductions

Chelsie Dubay welcomed new and returning members to the meeting then outlined the proposal review process. UCC members were given the opportunity to ask questions.

New Business

- Establish Program Policy – Allied Health Major, B.S. (Allied Health Leadership Concentration) - Progression

Landon Shields provided an overview of the program policy which requires students in the Allied Health Leadership Concentration to earn a C or better for all major course requirements. This is already a requirement in the other Allied Health programs; this proposal creates consistency across concentrations.

Prior to the meeting, the proposal was reviewed by all UCC members. UCC Members found the proposal to be well written with no areas of concern.

- Revise Academic Minor: Revise Advisor-Approved Electives – Fine and Performing Arts Studies

Scott Contreras-Koterbay provided an overview of the revision to the minor which was developed in response to requests from department chairs. In some cases, the specific listing of elective courses will be removed and replaced with a more general required number of upper-level class hours. In other cases, the chairs requested additional courses be added to the list of Advisor Approved Electives. There is no deletion of courses in this revision; specific courses removed from the list can still be taken with the director's approval.

- Revise Curriculum: Non-Substantive - BSEH Environmental Health

Rod Handy provided an overview of the program policy which gives students the option to select their science course based on their area of interest. Students could choose from HSCI 3000 Human Anatomy, GEOS 1110 Earth Sciences: Weather and Climate, GEOS 1500 Intro to Geospatial Technology, GEOS 3500 Geographic Information Systems, and/or PHYS 2011 Physics Laboratory.
