CALL TO ORDER:

With a quorum present, President Kerley called the meeting to order at 2:45 pm.

APPROVAL OF MINUTES:

The minutes of the October 7, 2002 meeting were unanimously approved,

OLD BUSINESS:

Senator Butler announced need for a CPAH representative for the Intercollegiate Athletics Standing Committee and the continued need for a Graduate Faculty representative and a Faculty-At-Large representative for to Library Committee.

NEW BUSINESS:

State of the University: Dr. Paul Stanton, ETSU President. President Stanton began his presentation to and discussion with the Faculty Senate with acknowledgement of a variety of "thorny" issues currently going on including the current mandates from TBR and indicated that he had asked Dr. Bach to accompany him as an additional resource for information. As far as the budget is concerned, ETSU ended up with an \$8 million increase in budget due to the increase in tuition and a change in appropriations that occurred 2-3 weeks ago. There will be a delay in the Step III pay increases of the equity plan until June 1 and an increase in insurance premiums by 25% on January 1, 2003. ETSU Faculty Senate

- Dr. Stanton also discussed the joint master planning which is occurring with the city of Johnson City for the 60 acres encompassing the reserve center areas. The College of Medicine is doing the front end funding through their Practice Plan and an application is currently being written for a TVA loan. Also discussed was the \$8 million from TDOT for development of the Gray Fossil site and development of a museum and teaching facility. ETSU has to raise \$2 million to match these funds.
- Other topics discussed included the approval of a Research Foundation to expedite research, the court ruling related to teacher pay and it's potential impact on higher education, the benefits and negatives of the lottery, the surcharges for digital media courses and the post-retirement plan.

ANNOUNCEMENTS:

Senator Fisher distributed voting information for Washington County precincts. Senator Patrick's report of the TBR Faculty Subcouncil meeting deferred until the next meeting.

The meeting was adjourned to committees at 4:00 pm.
