September 25, 1995

NEXT MEETING: October 9, 1995, 2:45PM, Culp Forum

CALL TO ORDER With a quorum present Donn Gresso called the meeting to order at 2:50 PM.

APPROVAL OF MINUTES The September 11, 1995 minutes were approved.

#### UNFINISHED BUSINESS FROM PREVIOUS MEETINGS

Update on Library Plans The update about the plans for the new ETSU library was presented to senators. A handout which accompanied the presentation is available at the Senate office.

SACS Follow-Up Report Dr. Bert Bach reported on a joint meeting of the Deans' Council, Chairs' Council, and Faculty Senate Executive Committee in regard to the action to be taken on the SACS Follow-Up Report. Those present at the meeting considered a format which had been suggested for collecting and reporting data to document the linkage connecting faculty evaluation, action taken on evaluation suggestions, and the outcomes of the action. It had been agreed at the meeting that the suggested format was appropriate for reporting quantitative data when accompanied by narrative or explanatory information, but that it was not appropriate for collecting data. A subcommittee had been appointed to study alternative data collecting formats.

Discussion of the Policy and Procedure for Use of Memorial Center and Brooks Gym After brief discussion, it was decided that concerns about the proposed policy should be addressed to the Faculty Senate Concerns and Grievances Committee. This committee will process and organize the concerns for presentation to the Senate.

University wide priorities to be addressed by the Faculty Senate and Priorities for the Faculty Senate Standing Committees Donn Gresso delivered a handout which displayed in matrix form the priorities set by the Senate and the Standing Committees.

#### **NEW BUSINESS**

Dr. Wilsie Bishop reported on plans for improvement of undergraduate academic advisement. Questions to be addressed in reviewing current academic advisement practices and needs are as follow:

- 1. Is academic advisement at ETSU effective?
- 2. What evidence of problems in academic advisement do we have, and what alternatives exist for addressing them?
- 3. What is the current commitment of financial resources to academic advisement, and are they well spent?
- 4. What are the implications for using new or existing technologies to address advisement?
- 5. What is the appropriate function for an office advising undeclared majors, and how should it relate to overall academic advisement at the university?
- 6. Should ETSU have mandatory academic advisement of all undergraduate students?
- 7. Is advisement of adult students adequate?
- 8. Are there other issues that warrant review?

Peggy Cantrell, Interim Dean of the Graduate School, informed the Senate of the 1995-1996 priorities at the Graduate School, as follow:

- 1. Develop and enforce effective policies, procedures, and protocols.
- 2. Promote and improve the service orientation and efficiency of the Graduate School office.
- 3. Enhance the role of the Graduate Coordinator and the Graduate Council.
- 4. Promote the Graduate School's leadership role in quality of education.
- 5. Develop strategic planning and databased decision-making.
- 6. Improve the graduate catalog.
- 7. Promote the Graduate School and graduate programs.
- 8. Develop a recruitment plan for the Graduate School.
- 9. Ensure the Graduate School's continued role in research and research training support,

Jane Melendez, 1994-1995 Chair of the Standing Committee on Race Relations, supplied Senators with the committee's annual report and recommendations.

Mark Steadman requested nominations for a Faculty Senator to serve on the Information Resources Council. No nominations were forthcoming.
