CALL TO ORDER With a quorum present Donn Gresso called the meeting to order at 2:50 PM.

APPROVAL OF MINUTES The March 18, 1996 minutes were approved.

#### UNFINISHED BUSINESS FROM PREVIOUS MEETINGS

Nominations for Senate Officers During the April 1, 1996 Senate meeting, nominations were made for 1996-1997 Senate officers. Jane Melendez and Steven Berk were nominated for President-elect. Stephen Patrick was nominated for Secretary. Mark Steadman was nominated for Treasurer. Nominations remain open through the beginning of the Senate meeting on April 15, 1996, the day of the election.

Report from the Ad hoc Committee on Academic Freedom under Tenure Paul Kamolnick reported that, when the current legislative bills which threaten academic freedom have been resolved, the committee's charge will have been completed and the committee will disband. At present, one bill remains under consideration. If further need for such a committee arises in the future, a new one can be formed. Dr. Kamolnick suggests that faculty, concerned with threat to academic freedom, join groups such as the American Association of University Professors and/or the Tennessee Education Association. These groups are active politically and keep their members informed of legislative activities which can impact educators and the educational process.

#### **NEW BUSINESS**

George Poole asked when the results from the salary equity study will be disseminated. Donn Gresso explained that the data is not yet complete, and that the results will be disseminated as soon as the study is complete.

#### **ANNOUNCEMENTS**

Donn Gresso reminded Senators that vacancies will be opened as terms expire. Each Senator going off should notify his/her college or academic unit of the vacancy, so a new Senator can be elected.

Bonny Stanley announced the 9th Annual Tennessee Collaborative Leadership Academy, to which faculty can apply for a fellowship. Dr. Stanley distributed a brochure about the academy and fellowship application. Copies may be obtained from the Senate office or from Dr. Stanley.

Donn Gresso announced that responses to the call for nominations and volunteers for committee membership, sent out by the Committee on Committees, are coming into the Senate office.

Donn Gresso announced that the FAP/FAR/FAE survey conducted by the Faculty Development and Evaluation Committee is being tallied by student workers.

Bill Fisher announced that funding for next year has not gone up from this year. However, the funding formula has been changed in such a way that some institutions will receive less money. ETSU is one of the institutions receiving less. Dr. Fisher recommends sending a Senator to the TBR meeting in June.

**ADJOURNMENT** The general Senate meeting adjourned at 3:35 PM, and Senators moved into their Senate subcommittee meetings.

The Bill contains many inaccuracies. In addition to being detrimental to Public School students, it is also detrimental to aspiring teacher candidates in preparation at higher education institutions in Tennessee.
