#### CALL TO ORDER

With a quorum present Donn Gresso called the meeting to order at 2:49 pm.

#### APPROVAL OF MINUTES

The April 15, 1996 minutes were approved.

#### OLD BUSINESS

#### □ COMMENTS/ACTIONS BY OUTGOING PRESIDENT

□ Donn Gresso welcomed the new faculty senators and thanked the returning senators for a productive year. Gresso reminded the committee chairs that reports for last year are now past due and that outstanding reports need to be submitted to him ASAP. Gresso adjourned the 1995-96 session of Faculty Senate and turned the gavel over to John Quigley, Incoming President.

#### **NEW BUSINESS**

#### □ ELECTION OF "AT LARGE" MEMBERS FOR EXECUTIVE COMMITTEE

Quigley turned the meeting over to Donna Robbins, Chair of the Elections Committee. Nominations were called for from the floor and the following senators were nominated for the three available one-year positions. Nominated were Steve Ralston (MCOM); Marian Clark (ENTC) declined; Steven Berk (INTM); Steven Brown (CJCS); Anne LeCroy (ENGL), and John Taylor (CUAI). The nominations were closed. Senators nominated were asked to stand so new members could see who the nominees were. Everyone was then asked to vote for three and Robbins and Steadman adjourned to count the ballots.

## □ ANNOUNCEMENTS ON PERSONNEL MATTERS AND BENEFITS

Bill Fisher reported on a variety of benefits and issues. Instead of a 25% increase in insurance costs there will only be an 8% increase. There will be a state sponsored "Health Insurance Benefits Fair" on campus on Wednesday, September 25th from 9am - 3pm. The Chancellor of TBR decided not to match contributions to individual 401k accounts for this year. Fisher

distributed copies of the Tennessee Optional Retirement Program (ORP) Annual Report which contains valuable information for new faculty members regarding TCRS and TIAA-CREF. Similarly VALIC has proposed changes (eliminating some options, adding new ones) for next year regarding optional benefits. Other information faculty members in the UT System can retire and teach part-time, TBR will be discussing a similarly phased retirement proposal. Fisher discussed the salary increase breakdown statewide. This stimulated a lively discussion of how the salaries were distributed on the ETSU campus. ETSU will make their budget presentation for 1997-98 to THEC on September 18th. In other news, THEC has approved private development of student housing for ETSU. This is a new situation worth watching.

#### □ ELECTION RESULTS

□ Robbins announced that the three senators elected to the Executive Committee for the following year were: Anne LeCroy, John Taylor, and Steven Berk.

## □ ELECTION OF TWO SENATORS FOR POSITIONS ON THE TEACHING AND LEARNING BOARD

- □ Robbins opened the floor for nominations for the one year term on the TLC Board. Mark Steadman was nominated. There being no other nominations, Steadman was elected by acclamation.
- □ Robbins opened the floor for nominations for the two year term on the TLC Board. Terry Tollefson was nominated. There begin no other nominations, Tollefson was elected by acclamation.

#### □ COMMITTEE ASSIGNMENTS

Quigley asked chair/representatives from each of the standing committees to give a brief statement of concerning their activities for the benefit of new senators in selecting committee preferences. LeCroy discussed the Academic Matters Committee; Berk discussed the Concerns and Grievances Committee; Robbins discussed Elections; Kamolnick discussed Development and Evaluation; Tollefson discussed Research; and Steadman discussed Committee on Committees activities. Quigley then asked members of each committee to stand and be recognized. New senators were asked to write down their 1st-2nd-3rd committee preferences. Senators will be notified of their committee assignments at the new meeting.

#### □ INTRODUCTION OF NEW SENATORS

#### □ CLARIFICATION OF SALARY RAISES REPORT

□ Ed Williams asked for a clarification of the salary raises report. Dr. Bach responded to the question and explained that there was a 2% raise pool not stipulated as across the board. Raises for faculty fell primarily into two categories: 1) intradepartmental equity (Twaddle study) of which 100% of these adjustments were funded; 2) interdepartmental market study of which 61% of these adjustments were funded. All other employees, including staff and administrators, received an \$800 raise.

#### ☐ ISSUE OF MINIMUM WAGE FOR STUDENT WORKERS

☐ George Stanton asked the question about minimum wage raises for student workers. Dr.

Bach responded that this would be discussed in Academic Council.

#### □ ANNOUNCEMENTS

Quigley gave the senators an update on the progress of the Presidential search. He distributed to the advisory committee copies of the faculty senate resolution regarding qualifications for a new president, as approved by the Faculty Senate in 1991. By mid-September all applications should be received. The first cut of applications down to 15 will be made by October 4th and a second cut of applications to the top 3 to 5 candidates will be made by October 11. The TBR Chancellor will make visits to the home campus of each candidate. Final candidates will visit ETSU and will have an opportunity to meet with the faculty at large. Quigley encouraged senators to motivate their college faculty to get involved with the search process and to obtain feedback from them. Following the visits the advisory committee will recommend a ranking of the final candidates. The Chancellor will make the final decision. Discussion followed. Tollefson asked about the criteria and suggested that the new president has demonstrated visionary experience in an academic enterprise.

#### □ MISCELLANEOUS DISCUSSION

- □ Steve Brown brought up the issue of the Kingsport editorial regarding ETSU is not known for excellence. The editorial highlighted the lack of quality of education as opposed to the quantity of the number of students. The article showed a lack of sensitivity of the community. A response was generated by Fred Sauceman.
- □ Comments raised the question as to adopting a statement to advise and/or revise the criteria for the presidential search. This item should be placed on the NEXT agenda.

#### □ FACULTY SUB-COUNCIL MEETING OF TBR.

- Quigley attended the last meeting and reported that the tenure issue has been raised. This relates to the tenure process and faculty evaluation on a regular basis. There is some concern that faculty elsewhere is not given post-tenure review. ETSU reviews all faculty on an annual basis. Quigley will represent ETSU at the Faculty Sub- Council meeting in Cleveland TN. The Provost at the University of Memphis will report on post-tenure review at this meeting.
- □ Dr. Bach responded. Two cohorts of faculty were tracked from 1987-88. Issue 1 was how many were tenured and how many left the institution. Issue 2 states the questioning on tenure evaluation as being one-time or continuing. Issue 3 tenure lends itself to obselescence when there is a lack of continuous growth.

#### □ FACULTY REPRESENTATION ON THE BOARD OF REGENTS

□ Fisher brought up the question as to how will active faculty representation on the TBR be enforced for 1996-97. He explained that there are six 4-year colleges/universities, fourteen 2-year colleges and 28 technical institutes. Since our state senator Rusty Crowe sponsored this legislation, Fisher asked who is the representative for the coming year. All indicators show that the active faculty representative is someone from Chattanooga Tech. Fisher feels that this person/representative should be active in the TBR Faculty Sub- Council committees and meetings. This situation should be monitored closely since ETSU is presumbably in the upcoming rotation.

#### □ ANNOUNCEMENT ON JOINT COMMUNICATIVE EFFORTS

Quigley introduced Mark Nabors, SGA President, and Jason Berry, SGA Vice-President, to the senate. He announced that he had met with Nabors, Marsh Grube (Chair, Council of Chairs), and Mary Jordan (President, Staff Senate). They decided that there should be a joint retreat among the officers of these organizations in order to improve communication between each and to come up with common goals. It was also suggested that there should be representation from the officers of the Graduate/Professional Student organization. Quigley concurred. In a similar measure, Dr. Bach commented that Academic Council along with the chairs of the Council of Chairs, and the presidents of the Faculty and Staff Senates have agreed to work on the continuous improvement issue of access, quality of enrollment, management and retention of students.

The Faculty Senate of East Tennessee State University respectfully requests that the university library building presently under construction on this campus be named the Roy S. Nicks University Library in general recognition of President Nicks' significant contributions to higher education in Tennessee over many years and in special recognition of his outstanding service as President of this University during the last five years, including the pivotal role he played in planning and securing funding for this much-needed facility. (A partial list of the accomplishments during his tenure as President of East Tennessee State University is attached.)

We further respectfully request that the present Charles C. Sherrod Library, when it is retrofitted to become the largest new classroom and academic office building in decades on this campus, be renamed Charles C. Sherrod Hall, to continue the fitting tribute to the distinguished service of this former University President.
